

[Required] Consent to the Collection and Use of Personal (Credit) Information

[Notification of Foreign Investment and Registration (or Change of Information) of a Foreign-Invested Enterprise]

To: Hana Bank

* In the event that the Bank collects and uses my personal (credit) information in connection with a non-credit (financial) transaction(s) with your bank, the Bank shall request my consent pursuant to the Use and Protection of Credit Information Act, the Personal Information Protection Act, and other relevant laws.

* Such a consent is necessary in conjunction with the following requests.

- Notification of Foreign Investment by Acquisition of Stocks (or Contribution)
- Notification of Information Change in Foreign Investment by Acquisition of Stocks (or Contribution)
- Notification (or Change of Information) of Foreign Investment in the Form of a Long-Term Loan
- Registration (or Change of Information) of Foreign-Invested Enterprise

Purpose of collection and use	- To verify nationality and identify relevant persons in order to receive a notification/registration
Duration of retention and use	<p>- Retained and used for five years from the year following the year in which registration of foreign investment has been canceled</p> <p>The head of an entrusted institution shall retain/manage documents relating to details of a foreign investment notification, etc. as semi-permanent documents. However, if registration of foreign investment has been canceled, documents should be retained for five years from the year following the year in which date of cancellation occurs.</p> <p>※ Basis: Foreign Investment Promotion Act, Public Records Management Act</p>
Right to refuse to provide consent, and disadvantages if exercising such a right	Consent to the collection/use of the aforementioned personal (credit) information is required in order to "sign and implement a contract including foreign investment notification." As such, in order to set up and maintain a (financial) transactional relationship, consent to the above matters is required.
